The Saki-Hikari Dealer Programme is an exclusive club of vetted and professional Authorised Dealers in the UK, who meet our criteria for supporting the brand. We will not supply Saki-Hikari to anyone who is not an Authorised Dealer.

The conditions of trade for the Programme are as follows.

- Saki-Hikari products can only be sold in their original packaging and must not be opened and sold in anything else. Products sold when damaged must still be in their original packaging to meet current UK and EU regulations.
- The product must be kept in a suitable environment away from chemical or bacterial contamination sources.
- Retailers can join mid-year but must buy retrospectively into the seasonal orders already sent that year at the point of joining.
- Inclusion in the dealer programme means you must pre-order and then accept delivery of all three seasonal orders.
- Should you place a seasonal order, and then not want it, we will unfortunately have to remove you from the programme for the remainder of the year.
- The three seasonal orders must be delivered in one drop, not in part.
- The three seasonal orders are the only time 5+1 FOC will apply items ordered outside of these will be sold at standard terms, advised from time to time.
- Orders can be added to after placing but not reduced.
- It is the responsibility of the Authorised Dealer to advise PWL Ltd. of any defect attributed to a Saki-Hikari product which may result in injury or illness to a consumer's livestock.
- We will only supply Saki-Hikari to those dealers who have one of the following:
  - o A Retail Store and / or
  - o A Transactional Website
- Unless you are a long-term Saki-Hikari Dealer (a Grandfathered Account) we will no longer open or supply new accounts at any residential addresses.
- The following third-party platforms are not appropriate for the sale of Saki-Hikari:

  - o B&Q Online
  - o Gumtree
  - o Vinted

- Requests to join the Saki-Hikari Dealer Programme will be treated fairly, considering the nature of the business applying, geographical location, experience and delivery access. We may discuss your application with existing Saki-Hikari Dealers.
- Saki-Hikari may not be supplied to any customer outside of the United Kingdom.
- Saki-Hikari may not be sold onwards to other retailers who are not Authorised Dealers.

- It is a requirement of the programme that Authorised Dealers will train their employees on the correct way to sell Saki-Hikari, provide them with the Saki-Hikari Technical Manual and ensure that they sell the product suitable for the consumers needs.
- Saki-Hikari should be date rotated correctly, using the first in, first out principle.
- PWL reserve the right to remove customers from the Saki-Hikari Dealer Programme should we find they are acting in any way that is damaging to the brand. This will include all the above conditions and others not listed here. We would encourage all Authorised Dealers to confirm with PWL Ltd first, if they wish to sell Saki-Hikari in a non-standard way, or on a new third party platform.
